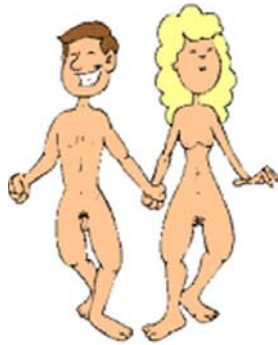
## Message from "da Mayor"

## Nude Cruise Update



To help celebrate National Nude Recreation Week in early July Friends of Little Beach has confirmed its 7th Annual Nude Rec Week Nude Cruise for Sunday, July 11. This will be an afternoon cruise with boarding starting after 12:30 for cruising from 1 to 4:30 PM. We will be aboard the "new" Maui Magic which leaves from Slip #55 at Maalaea Harbor. The cost of the cruise is \$45 per member (\$85 per member couple) and \$50 for non-members. Sodas, beer and wine will be provided by the Maui Magic. Each cruiser is asked to bring a pupu to share for our dining pleasure. Snorkel gear and a water-slide will be available on the boat. As always, use plenty of sunscreen during the afternoon and bring hats and sunglasses for additional protection. Please remember to leave a generous tip for the crew as you leave the boat to show your appreciation for their efforts.

# The Beach and the Weather

Since it is difficult to write about one and not the other, here is a synopsis of both.

Maui has seen one of the wettest and dreariest winters on record. The clouds and rains started in late November and continued well into March. Only in the past couple of weeks have the clouds broken away for sunshine. The miserable weather accounted for hundreds if not thousands of visitors wondering why they chose Maui for their winter/Holiday vacation. Rainfall records were broken across the island starting with Hana where 17 inches of rain fell in a 24-hour period in late March. Normally dry and arid Kihei has received nearly 3 times its normal 7 inches of rain so far this year. Obviously all this rain has helped ease the drought conditions we have had for the last many years. Unfortunately a lot of the rain came too hard and too fast. As a result however the island has not been this green in a long time.



In addition to the wet there have been high winds and incredible surf throughout the winter. There have been 3 drownings off Makena this year (2 off Big Beach on 1/15 and 3/23 and one off Little Beach on 1/13). These were in just two of the periods of huge swells where breakers easily had 10-15 foot faces. Due to the swells and overall dangerous conditions, plus lack of safety personnel, Makena State Park was closed for one day 1/16 and again for 3 days 2/27-29. Other parks and beaches were closed across the island at various times during

the intense storms of this winter. Many roads have been closed due to flooding and/or debris from the water on the roads. Pi'ilani Highway was closed for part of a day at the South end due to rocks and gravel that washed on to the road from Maui Meadows. Drainage ditches and culverts could not handle the huge volumes of runoff across the island.

If all of that wasn't enough to keep people away from the beach, then the lack of sand on the beach was. Most of Little Beach was washed away in mid-January, as well as about half of Big Beach. After about a week the sand started coming back to Little Beach but Big Beach kept washing away. The trip to the path across the North end of Big Beach was outright treacherous for 4-6 weeks, well into late Feb. Then, to add insult to injury, LB, as small as it was, washed away again on March 2. But this time it reappeared in one day so that by Friday March 5 there was about 10-20 feet of beach available for sunning, when the clouds disappeared. Before and after photos are available on the website. The tides and surf are still playing with the sand so Little Beach is not back to where it should be. This also means one must pay attention to the tide times or risk getting wet. Fortunately, getting across Big Beach is almost normal now.

Big Beach lost 30-50 feet of sand from the water back toward the high land and at least 6-8 feet deep. This lack of sand in January uncovered some old perforated metal plates that were apparently put down in the '40s for war training exercises. Folks speculate that there are a lot more under the sand and water but it won't be known for sure until the sand leaves to uncover it. A significant amount of Big Beach has returned, but neither Big nor Little Beach is back to comfortable normal. We will provide updates on the website when significant, dramatic changes or events take place.☀



## New Additions

During your next visit to Little Beach you will notice a new addition at the beginning of the path from the parking lot (just inside the yellow gate). DLNR has installed a handicap-accessible portable toilet and picnic table on a concrete pad just to the right of the path. This will allow more members of the public to enjoy Makena State Park.

There is also a caretaker's cabin between the first and second parking lots that has recently been completed. The hiring process has begun to find a caretaker for the park who will reside in the cabin.☀

Equipped with the right addresses, the frugal traveler can both enjoy-and afford-the top attractions of this increasingly popular Hawaiian island. One of the most social spots on the island is Little Beach at Makena, just north of the better-known, 3,300-foot-long Big Beach (where there's free parking). The small strip of sand attracts nudists, Boogie boarders, and residents who chat the day away in this lovely, undeveloped, free-of-charge hideaway. ☀

## Makena Resort Rezoning Request

Makena Resort has applied to the County Council Planning and Land Use Committee for a rezoning of its land around the Maui Prince Hotel. Makena Resort is requesting rezoning of approximately 600 acres of its land of which 435 are already built out as golf courses (Makena North and South Courses). The remainder of the land is undeveloped. An additional 125 acres are already zoned for development.

The goal of this request is to make the County zoning designation consistent with the Kihei-Makena Community Plan. In this plan the land is designated as "hotel/resort" while the county designation is consistent with the plans Makena Resort made back in the '80s. The resorts present plan is to build 1100 luxury homes and condos and 89 time-share units on their land over a 20-year period. The request was submitted about 4 years ago.

Issues raised by opponents include water availability, highway and traffic capacity, lack of parks in South Maui, affordable housing commitment, ocean pollution due to rainwater runoff and damage/destruction of archeological-sensitive sites. Supporters site the investments the Resort has already made in road improvements, water transport systems to South Maui, beach access and parking improvements. They also credit Makena Resort with being a very good neighbor, unlike some others on Maui that go unnamed.

The County Council Committee started its deliberations on March 8. Several sessions were marathons, including one that started at 4:30 PM and ended at 3:30 AM the next morning.

Finally, on April 14th, five weeks after beginning deliberations, the Committee gave its final approval after attaching 41 conditions to the request. The request will now go to the entire County Council for approval. This will occur in June after the County Budget process is finished.

The Resort's plan should have little to no immediate effect on Little Beach since LB is part of Makena State Park. However, who can determine now what influence the Resort and new homeowners, condo owners and others may have on the future of park use, the beaches and other issues. If nothing else, usage of the park, beaches, parking lots and roads will continue to go up, in part due to the additional population the development brings to South Maui. ☀
